## Objective

 To understand patient experiences in their own words, including the benefits and challenges of using ruxolitinib cream

## Conclusions

- Overall, most patients with vitiligo express a positive attitude about starting and staying on ruxolitinib cream. Patients reported experiencing minimal side effects
- Although it can take a while to see positive results, patients share that repigmentation can continue to happen over time

# Take-Home Message

- Setting appropriate treatment expectations is an important aspect of staying on ruxolitinib cream treatment. This includes length of time to repigmentation, where on the body it is most effective, possible side effects, and what happens when stopping treatment
- Furthermore, educating both patients and healthcare professionals on how to navigate the insurance process and informing patients about available commercial programs may help eligible patients access and remain on therapy

# **Experiences With Ruxolitinib Cream in Patients' Own Words: A Social Listening Analysis**

## Introduction

- Vitiligo is a chronic, autoimmune skin disease that results in patches of skin depigmentation
- MyVitiligoTeam members organically share their experiences living with and managing vitiligo with one another
- This study examines recent treatment conversations centered on using ruxolitinib cream (Opzelura®), providing helpful information on patients' hopes, questions, and experiences with this new treatment option for vitiligo repigmentation

## Methods

- A passive methodology of social listening was undertaken by analyzing organic discussions about ruxolitinib cream among 168 unique members of MyVitiligoTeam posted from January 2022 to August 2024
- Additionally, results from a 2022 survey among 90 members of MyVitiligoTeam are included to provide the patient's perspective prior to FDA approval of ruxolitinib cream on July 19, 2022



### Results


- Previous MyVitiligoTeam survey research found that only 12% of 90 patients with vitiligo using any type of treatment were satisfied with their regimen
- Most patients were looking for a treatment that would repigment skin (79%), slow progression (52%), or diminish patches (51%)
- Prior to FDA approval of ruxolitinib cream, 47% of patients who stopped seeing a healthcare professional to treat their vitiligo were told that nothing could be done to repigment the skin
- Based on this social listening research, at least 81/168 members of MyVitiligoTeam had started to use ruxolitinib cream once available
- An additional 13 who had wanted to try ruxolitinib cream faced insurance or cost hurdles and were unable to start treatment
- In fact, some were told by their insurer that vitiligo is cosmetic in nature, which is inconsistent with the autoimmune nature of the disease, associated comorbidities, and the emotional toll of vitiligo on patients (Figure 1)

 Overall, the sentiment of 252 unique conversations related to ruxolitinib cream trended neutral (45%) to positive (32%). This included neutral discussions about getting ready to start treatment and positive discussions about effectiveness (Figure 2)

- Ruxolitinib cream treatment effectiveness varied among 81 patients, but twice as many reported positive outcomes (n=31) than
  negative outcomes (n=15); the remainder were either just starting on treatment or patiently waiting to see results
- Results ranged from quick results when applying ruxolitinib cream to specific body parts, particularly the face, to patiently waiting
  for repigmentation. Some patients started by applying ruxolitinib cream to limited areas of the body, focusing on areas that are most
  bothersome (Table 1)

I have it on my hands, hips, corners of my mouth, parts of my arms, and back. I'm hoping that the areas on my hands, especially, are able to recover some color." • MyVitiligoTeam members (N=81) reported experiencing minimal side effects (n=8). Only a small number (n=8) stopped treatment, with 7 citing lack of repigmentation. This suggests that patients are interested in a long-term treatment and understand that repigmentation takes time

- The organic discussions highlighted several questions and concerns that patients have about ruxolitinib cream treatment use
- These included expectations around repigmentation (extent, evenness, where on the body it works best), compatibility with other products (self-tanners, retinol creams, etc.), the possibility of relapse if stopping treatment, and concerns about the long-term use of the treatment given its cost (**Figure 3**)
